Corporate Governance Listing Requirements: Investor Protection from Fraudulent Financial Reporting

This paper analyzes the corporate governance listing requirements of major stock exchanges to assess the level of investor protection from investment disasters such as corporate financial reporting fraud (e.g. Enron and Parmalat) and the current subprime mortgage mess. The effectiveness of these corporate governance listing requirements in protecting investors are assessed by determining how they address ten common corporate governance factors in fraudulent financial reporting that represent lessons learned fraud scandals and the submitted memory memory. This comparison reveals that the listing requirements protect investors from some but not all of the ten commonly occurring fraud factors.
